**NOTES:** 

- The number of children from low-income families multiplied by a school's per-pupil allocation = total school allocation (TSA)
- A school's parental involvement allocation should not be included in the school's TSA.
- The sum of parental involvement allocations for all served schools must be at least 95% of the 1% required reservation for parental involvement.
