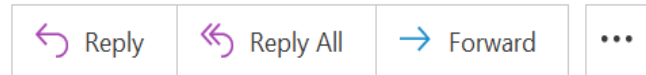

Eligibility for Title I Private School Equitable Services during the 2021-2022 School Year

Dear Sarasota County Private School Parent/Guardian:

The Florida Department of Education (FDOE) requires school districts to provide timely and consultation with private school leaders regarding their intent to participate in equitable services for students, parents and families, and teachers in non-public schools.

Private School Equitable Services funds are available to Private Schools under Title I, Part A Academic Achievement of Children.

To determine the equitable share of Title I funds your child's private school is eligible to receive, Schools must determine the "number of low-income students that reside in participating public school attendance school areas" at your child's private school.

Your responses will be treated confidentially. It is not necessary to provide your family and address, however, your address is required to verify the public school attendance zone.
